All lots, tracts or parcels of land embraced in this plat are subject to and shall be sold only under the following restrictions:

No lot, tract or portion of this plat shall be divided and sold, or resold, or ownership changed or transferred whereby the ownership of any portion of this plat shall be less than its platted area.

No permanent structure or building shall be constructed on any lot, tract or parcel of the plat closer than 30 feet to the right-of-way margin of any street or road, EXCEPT as shown on the plat.

Lot owners shall be prohibited from blocking, diverting, or restricting any natural or constructed drainage course following original reasonable grading of roads and ways thereon.

Construction on any lot shall require a building permit and a sewage disposal permit prior to commencement of work.
